INTRODUCTION

The Bisra Stone Lime Company Limited (BSLC) is a Government of India Enterprise , under the Ministry of Steel, Government of India. The Company is Listed at Calcutta Stock Exchange Limited. On 10.09.2009 Cabinet in its meeting , had approved the restructuring proposal. By virtue of Restructuring the outstanding Government loan has been converted into equity and thus paid –up capital of the Company has increased from Rs. 50 lacs to Rs. 87 crores 29 lacs. Thus, the public shareholding has reduced from 13.42% to 0.08%.

Now, Securities Contracts(Regulation) Rules,1957, has been amended on June 04,2010 and August 9th,2010. The Amended rule provides that “ Listed public sector company “which has public shareholding below 10%, on the date of commencement of the securities contracts (Regulation) (Amendment) Rule,2010(i.e. 04.06.2011) shall increase its public shareholding to at least 10%, in the manner specified by the securities and Exchange Board of India, within a period of 3 years from the date of commencement.

PROCESS OF APPOINTMENT

The company is in the process of engagement of consultant for expert opinion regarding raising ceiling of minimum public shareholding of The Bisra Stone Lime Company Limited as per clause 40A of Listing Agreement .
