Appointment of IEMs: The person should be of eminent personalities of high integrity and reputation.

Person applying would enclose detailed bio-data. The details would include postings before superannuation, special achievements, experience, etc., in Government sector. It is desirable that the persons possess domain experience of the PSU activities or the relevant field with which they may be required to deal.

Persons appointed as IEMs in two organizations would not be considered for a third organization.

The normal term of appointment for an IEM would be 3 years, and it would be subject to renewal by the Commission thereafter. Please visit company's website www.birdgroup.gov.in to know about the company.

Role/Functions of IEMs: IEM would have access to all contract documents, whenever required. Ideally all IEMs of an organization should meet in two months to take stock of ongoing tendering process.

It would be desirable to have structured meeting of the IEMs with the Chief Executive of the organization on a monthly basis to discuss/review the information on tenders awarded in the previous month.

The IEMs would examine all complaints received by them and give their recommendations/views to the Chief Executive of the organization, at the earliest. They may also send their report directly to the CVO and the Commission, in case of suspicion of serious irregularities requiring legal/administrative action.

At least one IEM should be invariably cited in the NIT. However for ensuring the desired transparency and objectivity in dealing with the complaints arising out of any tendering process, the matter should be examined by the full panel of IEMs, who would look into the records, conduct an investigation, and submit their joint recommendations to the Management

The recommendations of IEMs would be in the nature of advice and would not be legally binding. At the same time, it must be understood that IEMs are not consultants to the Management. Their role is independent in nature and the advice once tendered would not be subject to review at the request of the organization.

The role of the CVO of the organization shall remain unaffected by the presence of IEMs. A matter being examined by the IEMs can be separately investigated by the CVC Act or Vigilance Manual, if a complaint is received by him or directed to him by the Commission.
