- Time for completion of work** : The work has to be completed within a period of 1 (one) Month from the date of issue of work order.
- Validity of Tender** : The tender shall be valid for a period of three months (90 days) from the date of opening of the tender.
- Details about the Transformer** : Distribution Transformer, 11/.433 KV, 100 KVA capacity, 3 Phase, 50 HZ, copper wound type. The tenderer are advised to inspect the 100 KVA burnt transformer before submitting the tender document.

Scope of Work:

The scope of the work covers the repairing of 100 KVA copper wound distribution transformer Under CSR scheme.

- Security Deposit/Retention Money** : 10% of total contract price as prorata to be deducted from every progressive bill towards security deposit. The security deposit will be returned after 90 days from completion of the job in all respect and successful handover of the said work. The security deposit will bear no interest.
- Liquidated damage** : ½ (half) percent per week from the schedule date of completion subject to maximum of 10% of total contract value. No Liquidated damage is applicable if the completion period of the work gets extended beyond the stipulated period of the contract due to no fault of the contractor.
- Risk Purchase** : In the event of failure to fulfill the contract terms and execution of work as per letter of contract/work order the OMDC reserves the right to make the contractual obligation carried out by alternative arrangements and OMDC shall recover from the contractor any additional cost involve therein.
- Insurance** : All necessary insurance to be done by the contractor till job is handed over.
- Price escalation** : No price escalation will be allowed by OMDC at any time for whatsoever the reason.

The Price Quoted : The tenderer shall quote his price which should include all Taxes, duties and all other levies applicable i.e. sales Tax, Income Tax, Custom duty, Contract Tax, Entry Tax, Service Tax etc. No extra cost will be entertained on account of any Taxes and duties.

Termination of Contract : OMDC reserves the right to terminate the contract either in part or in full due to reasons for delay in completion, bad working, or any other abnormalities noticed during construction work. OMDC shall in such event give seven days notice in writing to the contractor of his decision to do so.

Change of Quantity : OMDC reserves the right to vary the quantity of item or group of items to be specified in the specification for which unit price will remain unchanged.

Payment conditions : 90% of the total order value shall be paid against receipt and acceptance of materials at site.

10% of the bill shall be deducted and retained as security deposit and it shall be released after completion of the guarantee period i.e. 12 months from the date of commissioning of the job or 18 months from the date of delivery whichever is earlier.

Testing

Following tests are to be carried out by the repairer in presence of OMDC representatives during the process go repairing.

- a) Measurement of winding resistance
- b) Ratio, Polarity & Phase relationship.
- c) Load loss (Full load & No loss)
- d) Impedance voltage
- e) All category of insulation resistance.
- f) Induced over voltage withstand (DBDF)
- g) Separate voltage withstand (High voltage)
- h) Transformer oil BD value.
- i) Temperature rise.

ARBITRATION
